Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul> <li>NONE</li> </ul>
Non-affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <b>NONE</b>
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul> <li>NONE</li> </ul>
